He noted interest, legal expenses and insurance expenses and payables, resiliency loan 89%, ahead of where the bad debt write-off was, CDs maturing in the coming days and discussed the rates and detailed the plan for re-investment.

PALLADINO, SECONDED BY MR. CRIST, AND PASSED UNANIMOUSLY.
