Financial Reports and/or Requests for Payment

Mr. Kleiman reviews the income and expense summary, noting that the income YTD balance is \$452,588 and YTD expenses are \$92,094, with revenues exceeding expenses by \$360,494.

The balance in the bank and money market account is \$992,231.

Mr. Kleiman asks to obtain a motion to approve the vouchers and payments in the amount of \$26,491.56. Motion made by Ms. Rogulski, seconded by Mr. Schreibeis, that the Board accept the financial reports, authorize OCFC payments and vouchers. Open for discussion. Bnai Yoel, Inc - Presentation

Mr. Weiss presents on behalf of Bnai Yoel (BYI). The applicant is seeking a \$8M tax-exempt bond for the acquisition and eligible reimbursement for costs incurred for the acquisition of existing Boys School Buildings in Orange County. The subject properties are located in two jurisdictions in Orange County, New York: The Town of Monroe and the Village of Woodbury. The project will provide BYI with lower debt service and lower annual operating costs so that it can allocate its resources to further its core mission of education.
