#### August 10, 2017

A regular meeting of the Orange County Funding Corporation was convened in public session on August 10, 2017 at 3:38 P.M. at the Orange County Business Accelerator in New Windsor, New York...

Chairman Armistead calls to order the regular meeting of the Orange County Funding Corporation, August 10, 2017 Board consists of five members. There is a quorum.

Roll Call is taken.

#### **Minutes**

Review of the June 08, 2017 meeting minutes. Motion made by Mr. Schreibeis, seconded by Ms. Rogulski, to approve the minutes. Motion carries with all in favor.

#### Financial Reports and/or Requests for Payment

Mr. Kleiman reviews the income and expense summary, noting that the income YTD balance is \$712,976 and YTD expenses are \$192,569, with revenues exceeding expenses by \$520,407.

The balance in the bank account is \$1,152,145.

Mr. Kleiman asks to obtain a motion to approve the vouchers and payments in the amount of \$10,408.35. Motion made by Ms. Rogulski, seconded by Mr. Diana, that the Board accept the financial reports, authorize OCFC payments and vouchers. Open for discussion. Affirmative votes of all members present resulted in motion carried.

#### New and Unfinished Business

Mr. Dowd informs the board that the Bnai Yoel project has closed. The Sentinel is anticipated to close in the near future.

Ms. Villasuso informs that board that there has been a good deal of press recently regarding the Bnai Yoel Project. There seems to be confusion on the behalf of the general public which believes this is an IDA project. It is important to delineate the separation of the two organizations and to inform that assistance in refinancing of projects is part of the mission of the OCFC. Similar assistance was given to Mount Saint Mary in the recent past. It is important to stress that

the OCFC is only a conduit issuer of bonds and a party of the transaction, is not responsible for the debt, and does not collect the payment. Due to ABO compliancy, the projects are monitored throughout the process.
