MR. DOWD: Good morning everyone, my name is Kevin Dowd, I'm local counsel to the Orange County Industrial Development Agency. right is Kelly Reilly, one of our project coordinators and to her right is Fran Roth who is our stenographer who will be taking down everything that's being said today and provide a transcript to the board for their review. were supposed to livestream this meeting under a new state law but unfortunately we have some malfunctioning of our equipment so we will not be livestreaming it tonight, that's why the transcript's here as a backup, so that's good. So I'm going to read the public hearing notice and then I have a few things to say and then we'll open this up for the applicant to make a brief statement if they wish and open it up to public comment. Notice is hereby given that a public hearing pursuant to Article 18-A of the New York General Municipal Law will be held by the Orange County Industrial Development Agency

on Friday, January 31, 2020, at 10:00 a.m. local
time, in the meeting room at the Newburgh Town
Hall, 1496 Route 300, Newburgh, New York, in
connection with the following matter: DANSKAMMER
ENERGY, LLC, for itself or on behalf of an entity
formed or to be formed, previously received
certain financial assistance from the Agency in
connection with a certain project consisting of
(i) the acquisition by the Agency of a leasehold
interest in an aggregate approximately 52 acres
of land located on West Hudson River Road and Old
Post Road, each in the Town of Newburgh, New
York, Orange County, New York together with the
six existing generators located thereon
comprising the Danskammer Power Station, (ii) the
repair or replacement in kind of the damaged
components within the Existing Improvements; and
(iii) the acquisition and installation in, on and
around the Improvements of certain items of
equipment and other tangible personal property
including, but not limited to, piping and valves,
generators, pumps, electrical switchgear and
various instrumentation all for continued use as
a power plant. The Agency previously approved
financial assistance to the Company for the

Original Project in the form of (a) sales and use
tax exemption for purchases and rentals related
to the repair and equipping of the Facility, (b)
a partial real property tax abatement structured
within a tax agreement, and (c) if necessary, a
mortgage recording tax exemption for financing or
re-financing related to the Original Project.
The Company and the Agency entered into that
certain Tax Agreement, dated as of December 1,
2014, under the terms of which the Company is
required to make certain payments in lieu of real
property taxes to Orange County, the Town of
Newburgh and the Marlboro Central School
District; said Original Tax Agreement expires on
December 31, 2021. The Company has submitted an
application requesting the Agency to extend the
term of the Original Tax Agreement to December
31, 2025. The Agency is considering providing
financial assistance to the Company by extending
the term of the Original Tax Agreement. A
representative of the Agency will be at the
above-stated time and place to present a copy of
the Company's Project Application and hear and
accept written and oral comments from all persons
with views in favor of or opposed to or otherwise

relevant to the proposed Financial Assistance. Dated: January 16, 2020 by the Orange County Industrial Development Agency. The applicant, Danskammer Energy, filed an application on January 8, 2020, the IDA passed its initial resolution on January 9, 2020 authorizing this public hearing. Previous to that we had asked Danskammer to contact the affected tax jurisdictions and to get their approval for extension of the PILOT by a resolution dated October 17, 2019, the Marlboro Central School District adopted the following resolution. Resolved that the Board of Education upon recommendation of the Superintendent of Schools approves an amended community benefit agreement and extended PILOT with Danskammer Energy, LLC upon the attached terms and conditions and further authorizes the President to sign the amended community benefit agreement and extended PILOT; a full executed copy of which shall be placed on file with the District Clerk as presented. And that's a unanimous resolution of that school board. I'm sorry, yes, on December 23, 2019, the resolution of the Town Board in support of the application was also

adopted with four ayes and one abstention. that being said, I will turn this over to someone from Danskammer to make a brief statement. Thank you.

MR. REID: Thank you very much. I'm Bill Reid, I'm the C.E.O. of Danskammer and thank you very much for everyone who's here and thank you for letting us just make a few comments about this public hearing regarding the extension of our underlying PILOT. As many of you know we have been a local business here in the Hudson Valley for more than 60 years. We have an annual payroll of more than \$5 million and employ 42 local men and women. We are locally owned and operated. Danskammer was purchased by our group in December of 2017 and in auditing our financials we came to the conclusion there was a discrepancy in PILOT payments that amounted to about \$1 million. Without getting too much in the weeds, the discrepancy was about some special district charges were credited back to the primary PILOT payment. There was a misunderstanding about how that was done. reached out in July to the Orange County Industrial Development Agency and they asked that

we engage with the town and the Marlboro School District about this issue. We have had a continuous dialogue with both entities and as opposed to having the schools write us a check for about 75 percent of the discrepancy in funds which was their portion everyone thought that it made more sense to have an extension of our existing PILOT and in order to achieve the goals and allow us to remain the major contributor to the community that we are as part of their extension we'd clear up the language in the PILOT agreement surrounding the special district charges so this doesn't happen again. conversations with the town and the school district also resulted in an updated community benefit agreement for the town and the schools which weren't also working as they probably should have. As you well know, Danskammer is currently involved in the state's Article 10 permitting process to modernize our facility to make it cleaner and more efficient with the latest technology, stop using the Hudson River for cooling and lower electric rates in New York actually to about \$53 million a year. permitting process will take about a year from

application in December and we're waiting for it to be accepted by the Public Service Commission.

Any PILOT extension would only serve to get us through until we start building a new facility and if there's a new PILOT agreement that would be negotiated to cover the new facility it would supersede this extension. That really concludes my comments and I'm very happy to hear from others regarding the extension or answer any questions anybody might have.

MR. DOWD: Thank you. So now I'll open it to the public, ask you to step up to the microphone, give your name and comments.

SUPERVISOR PIAQUADIO: Hi, so I really want to thank the IDA for having this public hearing here today.

MR. DOWD: Can we have your name please? I know who are but--

SUPERVISOR PIAQUADIO: Gil Piaquadio,
Supervisor of the Town of Newburgh and I live in
the town also. So the Town of Newburgh supports
extending the existing PILOT for four years on
the existing Danskammer Power Plant for the
following reasons. Increases payments to the

Town of Newburgh, County of Orange and Marlboro Central School District. This extended PILOT will eliminate any overpayment as a result of a conflict in wording which will be corrected and made clear in this extended PILOT. does not apply to any redevelopment of the new Danskammer plant under the Article 10 and I wanted to read even though you know, you already have it, the resolution was approved by my town So here it is. Councilwoman Greene board. presented the following resolution which was seconded by Councilman Manley. Whereas, the Town of Newburgh Town Board heretofore by resolution adopted on August 4, 2014 and October 6, 2014 authorized letters of support to be delivered to the Orange County Industrial Development Agency for the applications of Danskammer Energy, LLC to the Orange County IDA. So that among other things a deviation Payment in Lieu of Taxes called a PILOT agreement dated December 1, 2014 in connection with the improvement and repair of the Danskammer Power Generating Station, the existing PILOT could be approved and executed by the Orange County IDA and Danskammer. whereas, the Town Board is advised that

Danskammer will be applying to the Orange County IDA to amend and extend the existing PILOT for a period of four years and that if said application is approved, a new extended PILOT agreement will replace and nullify the existing PILOT. whereas, the Town Board has been informed that the proposed extended PILOT will provide for annual increases in payments for the benefit of the County of Orange, Town of Newburgh and Marlboro School District, the affected taxing jurisdictions at the same rate as provided in the existing PILOT. And whereas, Danskammer has also informed the Town Board that it is willing to withdraw its claim for reimbursement under the existing PILOT based upon a disagreement over the calculation of credits due to Danskammer, if the extended PILOT is completed and with the Orange County IDA. And whereas, the extended PILOT will not apply to the redevelopment of the Danskammer Power Generating Station proposed in the pending application of Danskammer under the Article 10 of the Public Service Law without further amendment or replacement. And whereas, the Town Board has reviewed and considered the matter and finds that support for Danskammer's application for an

extended PILOT to the Orange County IDA is in the best interest of the Town of Newburgh so long as the payments are made under the extended PILOT on behalf of the affected taxing jurisdictions and are not reduced and any credits due to Danskammer based upon the payment of special district charges are limited to fire district charges. Therefore, be it resolved that the Town Board of the Town of Newburgh hereby supports the approval by the Orange County IDA of the application by Danskammer for the proposed extension, amendment and clarification of the existing PILOT between the Orange County IDA and Danskammer. And be it further resolved that the Town Board hereby authorizes and directs that a copy of this resolution certified by the Town Clerk be forwarded to the Orange County IDA and also authorizes the Supervisor to send further letters of support consistent with this resolution. be it further resolved that the resolution shall take effect immediately. And this was voted on by Councilwoman Greene voted yes, Paul Ruggiero, yes, James Presutti abstained, Scott Manley voted yes and I voted yes myself, so thank you.

MR. BROOKS: Thank you very much for allowing us to speak today. I'm Michael Brooks, Superintendent of Schools for the Marlboro Central School District. I want to say thank you certainly to Supervisor Piaquadio for being a spearhead on keeping the parties moving in the right direction. I know he shared jurisdictional responsibility because of the Town of Newburgh and the school district of Marlboro. The school district of Marlboro and the Board of Education unanimously adopted the resolution to support the extension of this PILOT revolving some matters that we had in disagreement and would request that the IDA take that seriously in its considerations as you decide on this short term extension. The existing PILOT is expiring so if we don't do some kind of extension there's no steps forward and it is an interim step. So that's an important piece for us, it allows us to settle the matter and prepare for the eventual rebuilding of the Danskammer plant which the Marlboro School District also supports. So that next phase in how we deal with, what the new plant is and isn't is to the school district and the town is obviously another important step and

we request that we be directly involved in that process. Thank you very much.

MR. DIORIO: I'm Todd Diorio, Hudson Valley Building Trades. I represent the trades council which is 28 local unions. I'm also a resident in Marlboro so I'm in the school district of Marlboro, so I'm hearing a lot about this power plant, most everybody that I know I speak to in town support the extension, it's much needed. The Article 10 process is long so, we don't know how long it's going to take before construction so they're going to need this extension to keep Danskammer up and going with affordable taxes. It's supported by the Town of Newburgh as you heard from Gil and the Marlboro School District. There's been a lot of support, I've attended a lot of meetings with Bill and Michele from Danskammer, I can't even count how many elected officials, how many meetings, this is much needed, this is one step closer to the new facility which Bill, I'm not going to get into details, it's a better facility than the old one. But construction, after they start it's 450 jobs, \$450 million roughly in construction, probably a little higher now as the longer it goes on. So

we definitely support this project and we support the extension. Thank you.

MS. HALAHAN: Good morning, Maureen Halahan, president and C.E.O. of the Orange County Partnership. On behalf of the Board of Directors of the Orange County Partnership we want to support this project. We know that the infrastructure is very much needed to continue our economic development efforts not only in the town but also in the county and the region. And this extension will continue to move them forward in the pursuit of making sure that this plant is fully operational. Supporting the infrastructure, the job creation is significant as is the ratables for the communities and we know as we have met with most of the elected officials ourselves and attended all the meetings that there's a tremendous amount of support for this project and we ask you to continue to do Thank you so much. that.

MR. DOWD: Anyone else? There being no further comments, I will declare the public hearing closed. I thank you for your attendance. (Proceedings concluded at 10:20 a.m.)
