NOTICE OF PUBLIC HEARING ON PROPOSED ISSUANCE OF BONDS

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Orange County Industrial Development Agency (the "Agency") on the <u>5th</u> day of <u>June</u>, 1998, at <u>10:00 AM</u>, local time, at the Rhinebeck Room, Glen Arden, Inc., 6 Harriman Drive, in the Village of Goshen, Orange County. New York, Room 301, in connection with the following matter:

Glen Arden, Inc. (the "Company"), a New York not-for-profit corporation, having offices at 6 Harriman Drive, Goshen, New York 10924, has submitted an application to the Agency to have the Agency issue its life care community revenue bonds in a principal amount not to exceed \$30,000,000 for the purpose of financing a certain project (the "Project") consisting of (1) the refunding of the Agency's Life Care Community Revenue Bonds (The Glen Arden, Inc. Project), Series 1994, issued on December 28, 1994 in the original aggregate principal amount of \$48,510,000 (the "Series 1994 Bonds"), and (B)(i) the construction of certain additional improvements to the Facility (as hereinafter defined) consisting of the conversion of the four existing two-bedroom independent living units into eight one-bedroom independent living units and (ii) the acquisition and installation in and around the Facility of certain items of machinery, equipment, furniture and other tangible personal property (collectively, the "Series 1998 Improvements"). The proceeds of the Series 1994 Bonds were applied to pay for the acquisition, construction and equipping of a life care community located on an approximately 41 acre parcel of land at the intersection of Harriman Drive with New York State Route 17, in the Village of Goshen, Orange County, New York (collectively, the "Land"), and consisting of (i) an approximately 245,000 square foot building containing approximately 163 independent living units, a health care center containing approximately 40 skilled nursing beds. common areas, including, without limitation, dining rooms, kitchens, activity areas, lobbies and other facilities, (ii) an approximately 3,000 square foot building to be used for administrative offices and an information center, (iii) parking facilities, and (iv) other related and appurtenant facilities (collectively, the "Improvements") and certain machinery, equipment, furniture, fixtures and other items of tangible personal property to be installed in and around the Improvements (collectively, the "Equipment"; the Land, the Improvements and the Equipment shall be collectively referred to as the "Facility").

Pursuant to Section 859-b of the New York General Municipal Law, the Company has submitted to the Agency along with its application, copies of the following materials: (i) its completed application to the New York State Life Care Community Council (now known as the Continuing Care Retirement Community Council)(the "Council") for a certificate of authority under Article 46 of the Public Health Law of the State of New York ("Article 46") with respect to the Facility; and (ii) the documentation establishing the Council's approval of such application; (the aforementioned materials, along with the Company's application to the Agency shall be hereinafter collectively referred to as the "Application Materials"). Copies of the Application Materials shall be made available for public inspection during regular business hours at the following locations within Orange County: the office of Clerk of the Orange County Legislature, Orange County Government Office Center, 252-272 North Main Street,

in the Village of Goshen, New York and the offices of Henry J. Holley, Esq., counsel to the Agency, 76 East Main Street, Port Jervis, New York.

The Agency is considering whether to undertake the Project and to provide financial assistance with respect to the Project in the form of: (A) the issuance by the Agency of up to \$30,000,000 aggregate principal amount of its life care community revenue bonds (the "Bonds"), to finance (i) all or a portion of the cost of refunding the Series 1994 Bonds and acquiring, constructing and installing the Series 1998 Improvements; (ii) certain incidental costs incurred by the Issuer and the Company in connection therewith, and (iii) the funding of a debt service reserve fund securing the Bonds; (B) the grant by the Agency of a mortgage on the Facility to secure the Bonds, which mortgage would be exempt from all mortgage recording taxes imposed by New York State and all political subdivisions thereof; and (C) the continued retention of fee title to the Facility by the Agency for a period of time not to exceed the term of a certain Agreement For Payments In Lieu of Taxes, dated November 15, 1994, previously entered into by the Company with each of the municipalities and school districts having taxing jurisdiction over the Facility (collectively, the "Affected Taxing Jurisdictions"), whereby the Company will make payments in lieu of real property taxes in such amounts as were approved by each of such Affected Tax Jurisdictions.

If the issuance of such Bonds is approved by the Agency, (i) it is intended that interest on such Bonds will be excluded from gross income for Federal income tax purposes. pursuant to Section 103(a) of the Internal Revenue Code of 1986, as amended, (ii) the Facility will be leased or sold by the Agency to the Company pursuant to a sale agreement (the "Agreement") requiring that the Company or its designee make payments equal to debt service on the Bonds and make certain other payments, and (iii) the Bonds will be special obligations of the Agency payable solely of certain of the proceeds of the Agreement and certain other assets of the Agency pledged to the repayment of the Bonds. THE BONDS SHALL NOT BE A DEBT OF THE STATE OF NEW YORK OR ORANGE COUNTY, NEW YORK, AND NEITHER THE STATE OF NEW YORK NOR ORANGE COUNTY, NEW YORK SHALL BE LIABLE THEREON.

The Agency will at said time and place provide a reasonable opportunity to all interested persons to present their views, either orally or in writing, on the location and nature of the Facility, the proposed plan of financing for the Facility by the issuance from time to time of the Bonds, or the proposed tax benefits to be afforded the Company in connection with the Project.

This public hearing is being conducted in accordance with Section 147(f) of the Code and subdivision 2 of Section 859-a of the New York General Municipal Law.
