MR. GINSBERG: Thank you, thank you, Bill and thank you to the members of the IDA and to those who may be listening remotely to entertain our phase two application for the project here in Goshen. As you may recall, the phase one project that we embarked on entailed the purchasing of or the building of a facility, a shell of a facility, some amount of infrastructure and the land associated with the facility. Phase two had always been planned to be an integral part and necessary part of phase one, it was done in separate phases as we were still gathering accurate information to be able to present to this board. Phase two, phase two consists primarily of capital expenditures needed to build out the interior of the shell that's being built to allow us to operate in the building. will help us to fulfill our commitment of hiring local workers, retaining local workers in an excess of 120 workers over the next several years. Without approval of this request, there may be a delay in some amount of the capital expenditure being spent over time and perhaps a delay in our fulfilling our being able to employ the correct number of employees, 120 employees.

We don't anticipate that to happen but I thank you for your consideration and look forward to your resolution.
