MR. FIORAVANTI: Good afternoon everyone, my name is Bill Fioravanti, CEO of the Orange County Industrial Development Agency. Today is the beginning now at 2:30 p.m. eastern time is the public hearing for Walgreens Eastern Company or otherwise known as Project Nucleus, a project that's come before the IDA for financial incentives. Before we begin, I'd like to ask that everyone stand and follow me in the Pledge of Allegiance.

Notice was hereby given that a public hearing in accordance with the foregoing and pursuant to Section 859-a of the New York General Municipal Law is being held electronically via Zoom by the Orange County Industrial Development Agency on the 14th day of February 2022 at 2:30 p.m. local time. holding it via Zoom due to the Covid 19 pandemic. Comments were invited to be submitted to the Agency in writing and to be delivered to the Orange County IDA at 4 Crotty Lane, New Windsor, New York to my attention or submitted electronically to business@ocnyida.com, in either case to be received by no later than February 10, 2022. Any written comments so received will be read into the record at the public hearing. should note that we have not received any comments or questions in writing either electronically or via mail to our office. following project is the subject of this public Walgreen Eastern Co., Inc. or an entity hearing.

to be formed heretofore known as the Company requested the Agency undertake a project consisting of the acquisition of a leasehold or license interest in approximately 215,000 square feet of improvements to be constructed on land located at or about 1396 Route 300, Newburgh, New York, tax map 60-3-49.22, use of approximately 105,000 square feet of the newly constructed building for a micro-fulfillment facility and medical and drug mini-warehouse to provide for automated medicinal distribution, the acquisition and installation in and on the Facility of furniture, fixtures and equipment, the granting of certain financial assistance in the form of exemptions from State and local sales and use tax, the appointment of the Company or its designee as an agent of the Agency in connection with the acquisition, equipping and completion of the project facility and the acquisition of an interest in the Land and Facility by the Agency pursuant to a sublease or license agreement and the acquisition of an interest in the Equipment pursuant to a Bill of Sale from the Company to the Agency and the sublease of the Project Facility back to the Company pursuant to a

sublease agreement as necessary. The company is the initial manager/owner of the Project. Agency will now hear all persons with views with respect to the proposed Financial Assistance to the Company, the proposed owner/operator, the location of the Project Facility and the nature of the Project. Miss Roth, I will note that I will send you a copy of that public hearing notice so you have everything verbatim. switch to the cost benefit analysis tool, a report that we did. The applicant to be clear is looking for only sales tax exemption on \$24 million worth of equipment that would be installed in this facility on Route 300 to create this micro-fulfillment center. Sales tax in Orange County is 8.125 percent so the total benefits being requested are \$1.95 million, again that's in sales tax exemption. So this equates to because of the, there's no construction labor being associated with this project, just the installation of the equipment and jobs being created as a result of this project happening, based on the jobs that are projected to be created in the first several years of the project we're talking local benefits and nominal value of

1	\$31,981,302, to private individuals that would be
2	\$31,763,350, to the public \$217,952, total state
3	benefits \$1,678,439 and total benefits to the
4	state and region \$33,659,741. Now a benefit
5	versus cost ratios, at the state level the
6	benefit is \$1.610 million, the cost is \$1.04
7	million, with a benefit to cost ratio of two to
8	one, locally the benefit again is \$30,699,499,
9	the cost locally is \$910,000, that is a ratio of
10	34 to one benefit to cost. That's the cost
11	benefit analysis. And now I want to remind
12	anyone that's looking to comment this is not a Q
13	& A, this is not a back and forth, we just ask
14	you to give you up to three minutes for comments
15	please and then at the end if there are some
16	questions it seems like there are some themes
17	that people want more answers to we'll try and
18	provide those answers or we'll follow up with you

21	see all of you, if you want to raise your hand I
22	will call on you to make comment at your
23	pleasure. Mr. Paquadio, Supervisor Paquadio, I'm

MR. PAQUADIO: Alright, thank you. I believe that this is a good tenant, I don't doubt it for one minute. But I think there's ways to attract a tenant sometimes other than just a sales tax break or whatever. I think perhaps the building owner should consider lowering the rent to this tenant in the way to entice or enhance From my point of view I cannot support a sales tax break to a corporation that's grossed like \$140 billion in 2020 and netted like \$456 million net and is 16th on the Fortune 500 list. It's a corporation that replaced General Electric on the Dow Jones. Granted, if that money was all spent maybe this town would receive about close to \$100,000. But that would be not just us, it would be the City of Newburgh receiving money, Town of New Windsor, every municipality in Orange County. And I can't see them being shorted in this case cause I don't really see the need with a corporation of this size. We really have residents living in this town paycheck to paycheck, many losing their homes because they're delinquent on either property or mortgages. mean, that being said, I cannot support a waiver

of sales tax for this applicant. That's the end of my comments. Thank you.

MR. FIORAVANTI: Would anyone else like to make a comment? Thank you, Mr. Supervisor, you didn't hear me say that, I apologize.

MS. LANCELLOTTI: If that's okay I would

like to.

MR. FIORAVANTI: Yes, Katie, please.

MS. LANCELLOTTI: Still weird to hear.

Thank you guys for the opportunity to speak and thank you, Bill, and the IDA and the Town of Newburgh. My name is Kaitlin Lancellotti and I am the Director of this expansion and retention with the Orange County Partnership and I'm here to speak in favor of Project Nucleus also known as Walgreens. So Walgreens is a worldwide distributor of high value products and pharmaceuticals with over 80 years worth of experience. This is a micro-fulfillment center and will elevate the customer experience and create new customer delivery and pickup services. This is a very big priority, a top priority for Walgreens with roughly a capital investment like

Bill said of over \$30 million with the creation

of 200 new jobs with a wide salary range with the

minimum starting at just 31,000 going up to \$165-ish. This is a huge win for Orange County and the Town of Newburgh. So on behalf of the Partnership and the organization and our board of directors, we want to fully support Walgreens project. Thank you.

MR. FIORAVANTI: Thanks very much, Katy. Would anyone else like to make a comment?

MS. HALAHAN: I would, Bill.

MR. FIORAVANTI: Please go ahead, Maureen.

MS. HALAHAN: Hi, sorry about the name on my computer, someone else must of used it but I'm Maureen Halahan, President and CEO of the Orange County Partnership. And I really just wanted to say briefly, I know that Katie just spoke and she really gave a very strong statement about how our board of directors feels about this project but what I wanted to say briefly is that this particular program the IDA offers is as of right, it's, I'm sorry, not as of right, anyone can apply for it and then be considered for this type of thing and it's not, it's elective by how much a company makes or who that is that's what we're vetting out here today. And some of these offerings, these incentives are brought by and

the reason why we support them is because New York is so highly taxed, it's so highly regulated and it's so difficult to operate a company in the State of New York and the landscape is unpredictable, you know, as well. So when there is incentives available that a company could use to help them as they're investing, you know, millions and millions of dollars in a community we support that and we want to make sure that, you know, that it's available to these companies and we applaud them for considering New York State, certainly Orange County and the Town of Newburgh. So again, on behalf of the board of directors of the Partnership, we do speak with that behind us that we want to see Walgreens here, we want to see them make their home here, create those kinds of jobs where so many will come to the communities and spend and, you know, generate more wealth and we hope that they will be considered today. Thank you.
