WHEREAS, the IDA has been informed that the parent entities and holders of membership interests in Danskammer Energy, LLC have entered into a Purchase and Sale Agreement with Danskammer Holdings LLC to convey 100% of the membership interest in Danskammer Energy, LLC; and

WHEREAS, pursuant to Section 6.3(a) of the Leaseback Agreement and Section VII of the Tax Agreement, the IDA's consent to an assignment in the ownership of Danskammer Energy, LLC is required; and

WHEREAS, the attorney for the prospective purchaser has requested that the IDA to authorize and consent to the assignment of the membership interests to Danskammer Holdings LLC; and

WHEREAS, Danskammer Energy, LLC will continue to own the premises and own and operate the power plant facility and will continue to be responsible for all obligations of the Leaseback and Tax Agreements; and

WHEREAS, as presently contemplated, the sale of the membership interests in Danskammer Energy, LLC will be financed in part by one of that entity's current owners and will be secured by a mortgage for which a mortgage recording tax exemption has been requested from the Orange County Funding Corporation; and

WHEREAS, the IDA wishes to authorize and consent to the assignment of the membership interests and the execution of any and all documents necessary to effect the purposes of this resolution.

NOW, THEREFORE, BE IT RESOLVED, that the IDA hereby authorizes and consents to the assignment of the membership interests in Danskammer Energy, LLC to Danskammer Holdings LLC.

FURTHER RESOLVED, that the IDA authorizes the amendment of the Lease Agreement to include the Orange County Funding Corporation as a party for the purposes of that entity to provide a mortgage recording tax exemption to Danskammer Holdings LLC.

FURTHER RESOLVED, that the IDA Bond Counsel and Local Counsel are hereby authorized to prepare all necessary documents in order to effectuate the provisions of this resolution.

FURTHER RESOLVED, that the Chief Operating Officer and/or Chairman of the IDA is hereby authorized to execute any and all documents necessary to effectuate the provisions of this resolution.
